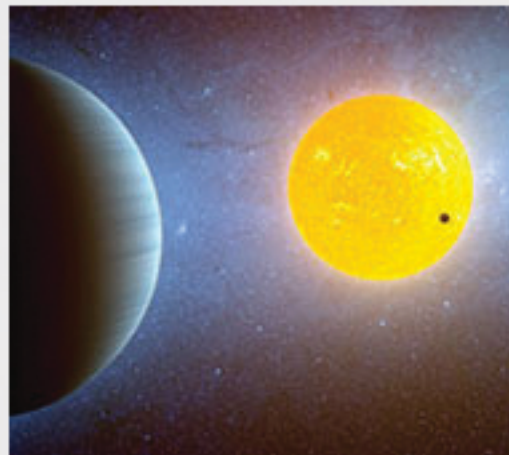

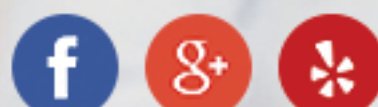
#### INGREDIENTS:
